Election of SFZS Directors

SFZS Board Chair Ed Poole presented the following slate of nominees for the Board of Directors:

Poole then announced that the following member has been elected to a two-year term ending in September 2024 as a Docent Representative: Mary Sutton.

In addition, Poole thanked the following, non-renewing member for his service: Arthur Humphrey.

Chair Poole then stated that as the Society has 23,000 members of record and the number of persons nominated to serve as directors is not more than the number of directors to be elected, pursuant to Section 4.5 of the Society's Bylaws, the nominated directors have been elected.

CEO Tanya Peterson welcomed and thanked SFZS members for supporting SF Zoo & Gardens this past year. She acknowledged long-term Docent Beth Anderson who was attending today's meeting and then presented on the 2021-22 fiscal year, including COVID-19's and recent economic markers affecting attendance. Ms. Peterson also reviewed pending construction projects; SFZS' updated vision statement to better reflect current priorities of the non-profit that manages SF Zoo; and discussed the weekend closures of the City's Great Highway at the Zoo's southern entrance and exit.
